2014 Cancer Program Outcomes: Screening Report



Community Mercy Health Partners has dedicated resources to breast cancer screening and early detection to those underserved and underinsured women in Clark and Champaign Counties.

This is a report to our community to describe our breast cancer screening efforts for the calendar year of 2014 and January 1 to September 30 for 2015.

Breast Cancer Rates Associated with the Springfield Regional Medical Center Program in 2014

In 2014 and 2015 Community Mercy Health Partners provided 9 screenings under the auspices of the Susan G. Komen grant award of \$14,200 and Jeff Wyler funded screenings during October. These screenings included breast health education provided by a RN, Nurse Practitioner provider breast exam with education and a screening mammogram via a mobile van with 2D imaging provided by Jewish Hospital in Cincinnati, Ohio (member of the Mercy Health system). These women were provided follow up and navigated by our CMHP staff depending on the outcome. Locations were determined based on areas designated as areas of underserved and uninsured populations. In 2014 the Springfield Regional Cancer Center Psychosocial Support Coordinator assisted women with the following services related to breast cancer screening and breast health related services:

- Women with Medicaid requiring a Primary Care Provider (1)
- Uninsured women needing a Primary Care Provider (1)
- Women who had a Primary Care Provider but were uninsured (4)
- Coordinated referral to the Rocking Horse Center for care – 4
- Expedited appointment for patient for diagnostic concern - 1
- Facilitated the transition to area Primary Care Provider - 2
- Referred to the following community support services/breast health assistance groups:
 - Breast Check Program – 1
 - Breast Cancer Endowment Fund – 3
 - Breast and Cervical Cancer Project – 3
- Coordinated the following services:
 - Preventative Mammogram – 7
 - Diagnostic Mammogram - 5

Dedicated Navigators are presently on site at the Springfield Regional Imaging Center and at the Springfield Regional Cancer Center located at 148 W. North St.

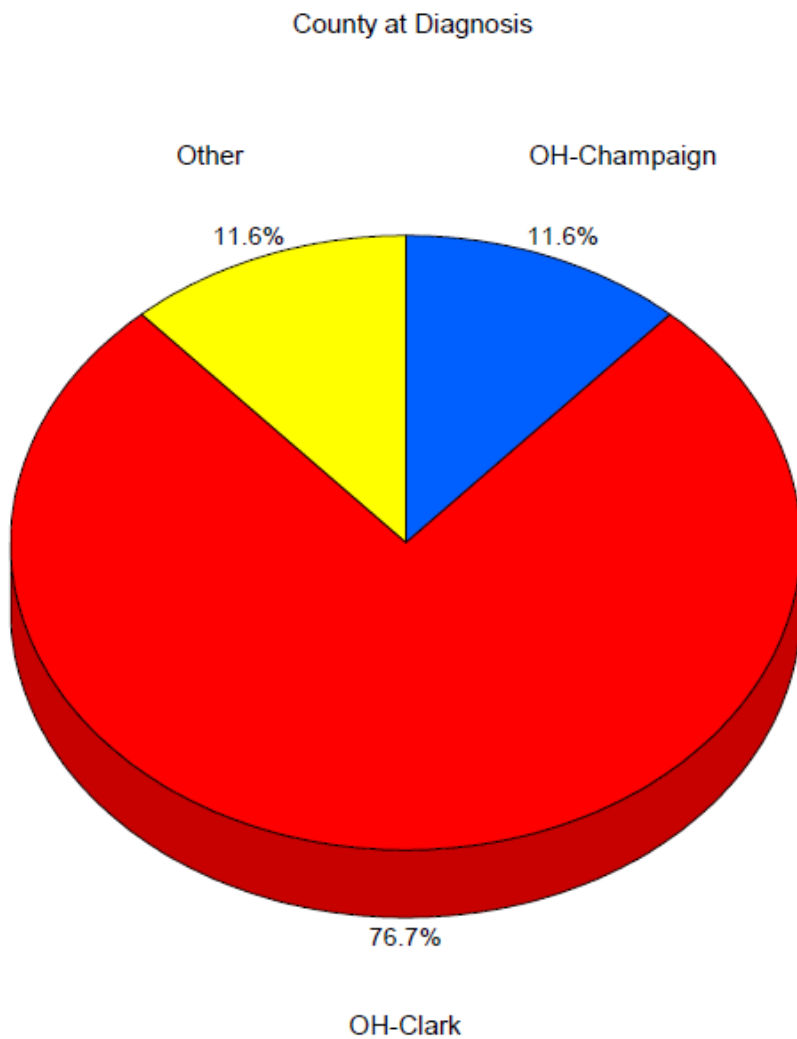
Outcomes related to Screening:

- Mobile Mammography provides a means for women to have screening at a location they may have health care services or visit
- Mobile Mammography grant has assisted in helping women who are underserved or underinsured to have screening accessible to them
- Mobile Mammography continues to be a resource for screening and utilized among Clark and Champaign County women
- Outreach has provided a means for women to initiate breast cancer screening and promote breast health awareness efforts
- In 2014, two participants on follow up were diagnosed with Invasive Ductal Carcinoma, one person with Stage I and another with Stage II. Both participants stated the mobile unit served as a means to complete their screening
- Action plan is to continue with the breast cancer mobile mammography screenings and navigation efforts.

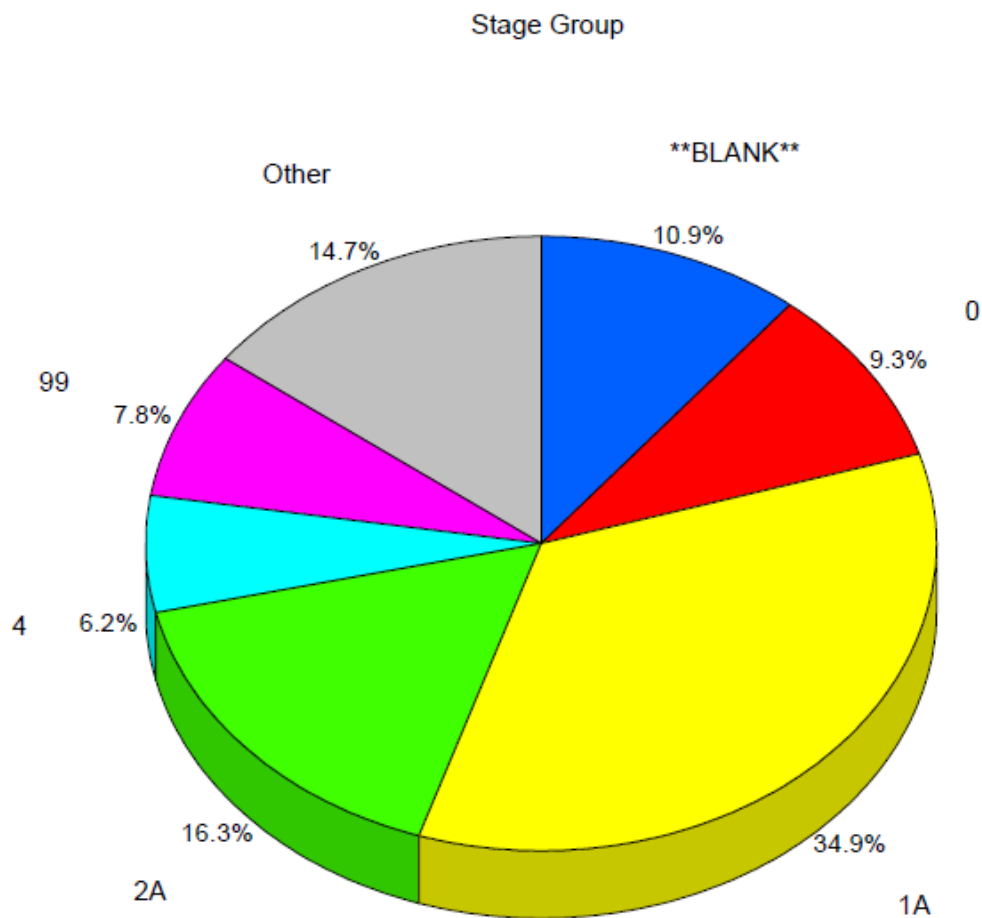
